

**TRAIL KLASSMARK REGULATIONS**

- These regulations explain the conditions of participation and the characteristics of the event.
- Completing the registration implies full acceptance of these regulations and the waiver of liability documents.
- Participation in the event implies acceptance of all environmental and sustainability measures, as well as the waste reduction policy established by the organization.
- All technical aspects can be found in the technical sheets available on the official event website.
- These regulations, as well as schedules, routes, and technical sheets, may be amended, modified, or improved at any time by the organization.
- Completing the registration implies acceptance and authorization of the cancellation and modification policy for the registration and the event.
- Completing the registration implies acceptance of having previously informed oneself of the route and technical sheets.
- Completing the registration implies acceptance of all schedules, services, and the participant's gift (if applicable) offered by the event.

**1. NO NATURE NO FUTURE**

- 1.1 Participants must prioritize ethics, sportsmanship, and respect for the environment above the event itself.
- 1.2 Events take place in fragile and sensitive natural environments. It is strictly forbidden to leave any trace behind.
- 1.3 Events are held in natural environments. It is strictly mandatory to preserve and protect ecosystems and their biodiversity, complying with the current regulations of each area.
- 1.4 Participants must respect wildlife and plants and remain silent whenever possible to prioritize the wildlife of the area.
- 1.5 Events take place in agricultural and livestock areas. Farmers and livestock will have priority along the entire route if encountered by participants.
- 1.6 Events take place largely on privately-owned natural land. Landowners will have priority along the entire route if encountered by participants.
- 1.7 Each participant must act responsibly and display exemplary behaviour in the face of any adversity.
- 1.8 Participants must not leave the marked paths.
- 1.9 Participants must respect fences, gates, and any other type of barrier related to livestock safety or private property.
- 1.10 It is forbidden for any participant to discard energy bar wrappers, gel packets, or any type of waste, including fruit peels.



NO NATURE NO FUTURE

- 1.11 Recycling correctly is strictly mandatory.
- 1.12 Any disrespectful action towards the environment, wildlife, flora, or local people will result in immediate and permanent expulsion. Attention: zero tolerance!

## **2. ATHLETES FOR ATHLETES**

- 2.1 If a participant, a third person, or any animal is in danger, it is mandatory to provide assistance (the event management will consider returning the time spent on providing aid).
- 2.2 Participants must alert the phone number provided on their race bib or the nearest control point of any type of incident.
- 2.3 If participants who have provided help have lost significant time, the event director will assess the situation and make the corresponding decisions.
- 2.4 In case of emergency, participants must call one of the phone numbers listed on their identification plate. These numbers are for emergency use only.
- 2.5 If assistance from the organization and/or rescue teams is required, they may take time to find you or reach you in extreme weather conditions, difficult access, and/or poor visibility.
- 2.6 Participants must accept and understand that they are taking part in a long-distance sporting activity in a natural and variable environment, where adverse weather conditions or areas of difficult access may occur. In case of a fall or injury, the medical team of the organization may take several minutes or even hours to reach the participant.
- 2.7 Participants assume responsibility for taking care of their own safety, acting prudently, and not taking unnecessary risks.

## **3. CLIMATE EMERGENCY**

- 3.1 Participants must be aware that climate change makes weather forecasting more difficult and be prepared in case the organization decides to cancel the event at the last minute.
- 3.2 The fight against global warming is our priority; for this reason, we will avoid giving or gifting participants any packaging, products, or materials derived from fossil fuels.
- 3.3 For this reason:
  - a) No single-use containers will be provided.
  - b) No participant bag will be provided. The gift and race number will be handed out directly.

- c) Participants must be aware that the organization works with local suppliers.

#### **4. REGISTRATION**

- 4.1 The registration fee will not be refunded.
- 4.2 Registration is not transferable from one year to another, nor will changes be made for other events in the Klassmark calendar.
- 4.3 Participants may change the name and distance of the registration, as well as other data, through “Your Registration” with the locator and email. To make the change, go to the website’s registration section: Home – My Registration.
- 4.4 One month before the event, no name or distance changes will be allowed. In case of a justified reason, a participant’s name or distance change may be requested by sending an email to [info@klassmark.com](mailto:info@klassmark.com).
- 4.5 The place will not be definitively assigned to the participant until payment is effective.
- 4.6 The organization reserves the right to cancel the event before the start if the physical integrity of participants is at risk due to weather or other external factors.
- 4.7 The organization is not responsible for additional expenses related to registration such as accommodation or travel in case of event cancellation.
- 4.8 If necessary, the organization may:
  - a) Modify the routes.
  - b) Activate alternative routes.
  - c) Modify the start times.
- 4.9 Registration will close once the participant limit has been reached or the announced deadline has passed.
- 4.10 The organization reserves the right to modify the number of participant slots.
- 4.11 The organization is not responsible for contractual relationships between participants and external services.

#### **5. CONDITIONS OF PARTICIPATION**

- 5.1 All participants must be of legal age on the day of the event. If not, they may participate only if they submit the “minor authorization” found in the “regulations” section. If the minor is under 16, they must be accompanied for the entire duration of the event.
- 5.2 Participants take part in the event voluntarily and under their own responsibility. For this reason, the organizing entity and company, the municipality, collaborators and staff, sponsors, and other participants are free from any civil liability.

- 5.3 By registering, participants automatically accept the “waiver of liability” which informs them of the risks of participation and excludes the organization from liability in case of any incident, accident, or contagion derived from participation.
- 5.4 By registering, the participant accepts all points of these regulations. Non-compliance with any of them will result in automatic expulsion.

## **6. EVENT DEVELOPMENT**

- 6.1 The route is open to other users, bicycles, vehicles, tractors, etc. Participants must follow public safety regulations and run cautiously at all times.
- 6.2 In case of any incident, the bib contains the phone numbers to contact the organization.
- 6.3 Once the maximum time to complete the route has been exceeded, all event services will be deactivated.
- 6.4 Participants may only receive external assistance in the designated assistance zones. Any other assistance along the route will be penalized.

## **7. WITHDRAWALS**

- 7.1 Participants who decide to withdraw must do so at a control point or aid station. Only a serious injury will justify withdrawal at another point on the course.
- 7.2 The organization will only commit to returning participants to the event start point if they have withdrawn at a control point or aid station with motorized access.
- 7.3 The organization reserves the right to return participants to the start point once the event has ended.
- 7.4 Participants who decide to withdraw must notify the organization.

## **8. ROUTE AND MARKING**

- 8.1 Es obligatorio seguir en todo momento el recorrido marcado con GPS. It is mandatory to follow the GPS-marked route at all times.
- 8.2 It is the participant's responsibility to know the course. The organization will provide the official GPS tracks and recommends carrying navigation devices to avoid mistakes.
- 8.3 If for any reason the route is left at any point, participants must rejoin at the exact same point where they left.

## **9. EQUIPMENT AND CLOTHING**

- 9.1 Carrying the appropriate equipment to face the event is the responsibility of each participant unless mandatory equipment is specified in the technical sheet. The organization reserves the right to modify this point up to the last moment.
- 9.2 Participants must dress and equip themselves correctly according to the technical conditions of the event and the weather.
- 9.3 The organization reserves the right to prevent a participant from starting or to stop them if they do not have the necessary equipment.
- 9.4 The organization recommends that all participants carry food and drink during the event. Sunscreen use is also recommended if required by exposure conditions.
- 9.5 The organization is not responsible for any lost or forgotten items during the event.

## **10. FORMAT AND CATEGORIES**

- 10.1 If the insurance is contracted through the organization, it will offer the following coverages and conditions:
- 10.2 The format and awarded categories will depend on each distance. You can consult the information in the technical sheets.
- 10.3 The participant's age on December 31 of the current year will be considered.
- 10.4 Prizes are cumulative.
- 10.5 It is mandatory to be present at the final ceremony to receive the trophy, medal, or gift.
- 10.6 Team events:
- 10.6.1. Participants in team events must complete the route with their partner or team, crossing control points and the finish line together. Otherwise, the team will be disqualified and excluded from the event.
- 10.6.2 If one team member withdraws and the other continues, they will not be classified as an individual under any circumstances.
- 10.6.3 The race director may apply any sanctions deemed appropriate after evaluating each situation.

## **11. PENALTIES AND DISQUALIFICATIONS**

### **11.1 Grounds for Penalty:**

- Throwing waste during the race: time penalty or disqualification.
- Not following the marked route: time penalty or disqualification.
- Not carrying the mandatory equipment: time penalty or disqualification.

- Disrespectful behavior towards other participants or the environment: time penalty or disqualification.

**11.2 External Assistance:**

- Participants may only receive external assistance in the designated assistance zones. Any other assistance along the route will be penalized.

**11.3 Violent Conduct:**

- Violent behavior against another runner, official, or spectator: time penalty or disqualification.

**11.4 Controls and Aid Stations:**

- No pasar por todos los controles de paso y avituallamientos: penalización de tiempo o descalificación.

**11.5 Respect for the Environment:**

- Disrespectful attitude towards the environment, wildlife, or flora: time penalty or disqualification.

**11.6 Discretion of the Race Director:**

- The race director may assess each action individually and modify the established parameters according to the severity of the facts.

**12. BIB COLLECTION**

**12.1** To collect the bib, participants must present identification. It is therefore mandatory to present an identity document (ID card, driver's license, or passport) and the federation card if federated. In addition, if not done previously, the waiver of liability must be duly signed.

**12.2** Bib collection by a third party is allowed, provided the following conditions are met:

- The participant has previously signed the waiver of liability.
- An authorization signed by the participant authorizing collection is presented (available on the event website).
- A copy of the participant's identity document is provided.
- The authorized person must identify themselves with their original identity document.

The organization reserves the right not to deliver the identification plate if these requirements are not met.

**12.3** The participant must know the coverage conditions of their insurer or federation.

**12.4** Reselling entries and participating with another person's identification plate may result in penalties for both the seller and the buyer, as well as possible legal action against both.

**13. DATA PROTECTION**

- 13.1 In accordance with Regulation (EU) 2016/679 of the European Parliament and Council of 27 April 2016 (General Data Protection Regulation – GDPR), and Organic Law 3/2018 of 5 December on Personal Data Protection and Guarantee of Digital Rights (LOPDGDD), we inform you that the personal data provided during the registration and participation process will be processed by the organization for the administrative and operational management of the event.
- 13.2 The data may also be used to send informative communications related to the event (briefings, logistical changes, additional services, results, photographs, etc.). In no case will they be shared with third parties without prior consent, except when necessary for the provision of services linked to the race (insurance companies, timing, medical services, etc.).
- 13.3 Participants have the right to access, rectify, delete, object to, or limit the processing of their data, as well as to data portability. These rights can be exercised via email at [info@klassmark.com](mailto:info@klassmark.com) or in writing to the organizer's address.
- 13.4 By registering, the participant declares having read and accepted this data protection policy.

**14. IMAGE RIGHTS**

- 14.1 All participants waive their image rights during the event.
- 14.2 The organization may use images taken during the event for the purposes of promotion, communication, and commercial and/or advertising exploitation of the sporting activity.
- 14.3 The right to one's own image is recognized in Article 18.1 of the Spanish Constitution and regulated by Organic Law 1/1982 of 5 May on the Civil Protection of the Right to Honor, Personal and Family Privacy, and to One's Own Image, as well as by Regulation (EU) 2016/679 (General Data Protection Regulation) and Organic Law 3/2018 on Personal Data Protection and Guarantee of Digital Rights.
- 14.4 Acceptance of these regulations implies that the participant authorizes KLASSMARK to capture images (photographs and/or videos) of their participation and expressly consents to their dissemination through any medium (press, social media, promotional materials, website, etc.) without the right to any financial compensation and solely for the purposes stated above. Under no circumstances will they be used for purposes other than those indicated.

**15. WAIVER OF LIABILITY AND CERTIFICATE OF PHYSICAL FITNESS**

- 15.1 I have read and fully accept the regulations.
- 15.2 I have valid medical insurance that covers participation in this sporting activity.
- 15.3 I am sure I am physically and psychologically prepared to participate in the event because I have undergone the appropriate medical checks to ensure that I am in

good health and do not suffer from any illness, allergy, physical defect, injury, or cardiorespiratory condition that would advise against my participation.

- 15.4 I am fully aware of the difficulty, route, profile, and distance of the event because I have checked it previously on the website.
- 15.5 I am aware that this type of event carries risks for participants. For this reason, I participate voluntarily and under my own responsibility, fully assuming the risks and consequences of my participation. I therefore release the organization, collaborators, sponsors, and other participants from any liability for any physical or material damage that may occur to me, and I waive any claim or legal action against them.
- 15.6 I have the technical knowledge and skills necessary to guarantee my own safety, considering the natural environment and the autonomy conditions of the event.
- 15.7 I have the sports and safety equipment required for the event. I guarantee that the equipment is in good condition, that I know how to use it correctly, and that I will carry it with me throughout the event.
- 15.8 I commit to following the safety rules and protocols established by the organization, as well as maintaining responsible behavior that does not increase risks to my physical or mental integrity. I will follow the instructions and accept the decisions taken by the organization's officials (judges, doctors, and organizers).
- 15.9 I authorize the event's medical services to provide any care or action they deem appropriate at any time during the event. I commit to withdrawing from the event and allowing my hospitalization if they consider it necessary for my health.
- 15.10 I authorize the event's organization to take and use any photograph, filming, or recording made, provided that it is exclusively related to my participation in this event, and I will not receive any compensation in return.
- 15.11 I will not consume prohibited substances considered as doping by the different federations before or during the event. The organization may carry out anti-doping tests on any participant.
- 15.12 I am aware that my bib is personal and non-transferable, so I will not give or sell it to anyone, even if I cannot attend the event.
- 15.13 I commit to following the general rules of respect for others and the environment, as listed below:
- a) Move cautiously and in accordance with traffic regulations, on tracks, trails, and roads open to traffic.
  - b) Move slowly in the presence of people, animals, or vehicles.
  - c) Not cause alterations in the natural processes and functioning of ecosystems.
  - d) Not damage biotic, geological, cultural, or other environmental resources.
  - e) Avoid sensitive environmental areas.
  - f) Relieve physiological needs in appropriate places, or in any case, away from water points and places where people pass or gather.
  - g) Not light fires or create situations with a risk of fire.
  - h) Not use or install any structure or element that leaves a permanent mark on the environment.



- i) Not throw or abandon solid or liquid waste outside of designated collection points.
- j) Not leave the marked route.
- k) Close any gates or fences for livestock that I have had to open on my way.

## **16. MEDICAL INSURANCE**

- 16.1 It is essential to have valid medical insurance that covers participation in this sporting activity. This insurance can be private, provided it expressly covers this type of activity and the participant declares it via the registration form, or it can be the insurance offered by the organization, which can be contracted during the registration process. No participant may take part in the event without having active and valid insurance.
- 16.2 If you have private medical insurance, you must go to the medical center corresponding to your policy so that the claim can be processed correctly by your insurer. The organization will not be responsible for any expenses generated by participants with private insurance who choose to go to a public health center or one not covered by their insurer.
- 16.3 If the insurance is contracted through the organization, it offers the following coverages and conditions:
- The sports accident must be reported on the same day of the event.
  - Medical or surgical care only in centers authorized by the insurer.
  - Unlimited medical and surgical care for sports accidents (up to 18 months).
  - Unlimited transfer or evacuation expenses to the authorized care center.
  - Orthopedic material expenses: up to 70%.
  - Rehabilitation treatments: unlimited, up to a maximum of 18 months.
  - Compensation for total or partial disability due to a sports accident: up to €12,025.
  - Compensation for death as a direct result of a sports accident: up to €6,015.
  - Compensation for death without a direct cause from a sports accident: up to €1,805.

## **17. PRIZES**

- 17.1 If applicable, all prizes awarded will be subject to tax withholding.
- 17.2 In the case of cash prizes exceeding €300, they will be subject to a tax withholding of 19% on the amount exceeding this limit. The prize will be paid with the withholding applied.
